

About The Award 關於獎項

The Residential Clubhouse Management Award was first launched by the Hong Kong Recreation Management Association (the Association) in 2011 and had received very good response. We have decided to launch this competition once every 2 years since 2013 after receiving feedback from the participants. Therefore, we launch this competition in 2023 after the last one held in 2021. The Association is a non-profit making organisation and has members from the recreation and sports fields who are the professionals or academics of the relevant field. The launching of this competition would arouse interests of those private residential management companies with provision of a wide range of recreation and sports facilities in their Clubhouse, and this would help raising the quality of services

All applicants are required to submit a written submission of not more than 50 pages to give details on the Clubhouse management based on the criteria in paragraph A on pages 4 to 6 and item 6 on page 10 "GUIDELINES ON WRITTEN SUBMISSION"

b. Stage 2 第二階段

After reviewing the written submissions by the Reviewing Committee, the final seven entries each for the two categories will be submitted to the Panel of Judges for the final decision

C. Stage 3 第三階段

The Reviewing Committee will conduct a site visit to the Clubhouses of the selected entries before the entries are judged by the Panel of Judges. The Reviewing Committee will interview employees and review the management of the club facilities during the site visit. The objectives are to verify the information provided as well as ascertain the level of management. During the visit of the Reviewing Committee, the applicant must provide the necessary arrangements to enable the smooth conduct of the site visit

The participants are required to do a 10- minute presentation of the submission to the Panel of Judges on the appointed date and time. The entry will be disqualified if the participant fails to turn up at the appointed date and time
